Re – Application for Tasmanian Forests Intergovernmental Agreement

As requested, to assist with your application for a contractor voluntary exit under the Tasmanian Forests Intergovernmental Agreement, we provide the following information extracted from Company log delivery records.

Gunns Limited hereby provides support for the contractor's application.

DM & SJ Iles Pty Ltd as of 24 July 2011 had an Ongoing Contract, as defined in the Grant Program Guidelines under Section 4, with Gunns Limited for either the harvest and/or haulage of native forest logs. A summary of the key contractual information required is detailed in Table 1 below;
