

***Submission to the Clean Energy Finance Corporation Amendment (Carbon Capture and Storage) Bill 2017***

The Clean Energy Finance Corporation should only be allowed to invest in clean energy.

Carbon Capture and Storage is NOT clean energy. This technology burns fossil fuels and creates Green House Gases. These need to be captured but it is impossible to capture 100%. Then they need to be transported to a storage facility, which is costly because there will never be one close to a power station, plus there will be further leakage. Then they need to be stored, for ever, in some caverns in the ground, possibly under the sea, from where it will be impossible to prevent further leakage.

All this will be extremely expensive, making fossil fuels even more uneconomic. Renewable energy is already cheaper to build, it costs nothing for fuel and does not cause global warming.

Global warming has already started to affect our climate, as has been experienced by our farmers. The sea is already warmer and half the coral in the Great Barrier Reef has already died. Wild weather is now more extreme and more frequent, costing billions in infrastructure damage.

The stability of the Earth's climate hinges on society's choice of energy supply. The use of non-cyclical indirect fuel such as oil, gas or coal lies at the root of the current instability. Fossil fuel derives from a natural process that extracted the atmospheric gases responsible for unstable climatic conditions, and sequestered them away as fossil fuel. The process required vast amounts of solar energy over a very long period of time. Raiding the energy content releases destabilising agents back into the atmosphere as pollutants. The problem is as simple as that. Burning fossil fuel along with the manufacture of cement from limestone are at the root of atmospheric pollution and climate destabilisation, not the use of energy. We are now destabilising the Earth's energy balance at a rate that is beyond the ability of most life forms to adapt to. Natural diversity is being lost and the support system for life as we know it is now in danger of collapse. Should it become necessary to re-capture the destabilising compounds, we can assume that the account rendered by Nature will include reimbursement of an equivalent amount of energy, possibly with interest. The sooner mankind starts paying its debts, the lower will be Nature's settlement demands.

As well as being a source of non-cyclical pollution, fossil fuel also happens to be an inefficient source of energy. The processes involved in bringing it to the market from its solar origins deliver a small fraction of one percent of the energy that was used to store the hydrocarbons in the first place. The organisms that the hydrocarbon reserves derived from were relatively inefficient solar energy converters compared to modern plants, the sequestering mechanisms she used for storing hydrocarbons had gross inefficiencies, Almost all the energy is lost to a combination of poor extraction efficiencies, compounded by parasitic losses attributable to transportation, processing and conversion processes.

Sustainable energy options are much more efficient. Modern plants such as sugar cane are capable of converting around five percent of the sunlight that falls on them into stored energy. Hydro-energy is a limited resource, but conversion of eighty percent plus of the energy available is possible. Modern wind turbines extract in excess of twenty percent of the wind's energy. Even nuclear energy and energy embodied in geothermal and hot rock resources can be extracted without producing climate destabilising pollution. The sensible use of cyclical or transient energy resources, including the direct conversion of sunlight, would have a positive impact on maintaining climate stability.

Direct conversion of sunlight is both efficient and relatively unlimited. Solar photovoltaic technologies are now capable of extracting in excess of thirty percent of the sunlight that falls on them each day. Combination solar photovoltaic/thermal technologies yield in excess of forty percent of the solar energy falling on them.

In fact there is no one technology that is capable of delivering all mankind's energy needs without destabilising the natural climate.

Future generations will view the legacy left by advocates of fossil fuel energy as environmental vandalism. It would be a big step forward if demands for energy were met using a mix of cyclical energy sources to meet base load demands, while limiting raids on fossil fuels to emergency situations.

The billions handed to the coal lobby by politicians who receive a fraction of that money back as donations are already wasted as far as the Australian public is concerned. I respectfully submit the following regarding the Government's plans to change the rules around investment by the Clean Energy Finance Corporation (CEFC).

I oppose changes that would allow CEFC to invest in carbon capture and storage (CCS) projects and seek that the Senate reject these changes.

The main reasons follow:

CCS has a poor track record. It has benefited from significant investment from governments both here and abroad. This has resulted in few large-scale plants and the capital and operational costs of these have made them uneconomic. Further investment in these investigations will be a waste of money.

There are many more promising alternative investment opportunities. Sustainable energy operations are now cheaper than conventional ones. Seen the energy used and environmental destruction to get each ton of coal to a rail head it makes me ever more happy that I have transitioned to a form of renewable energy, solar. Truly solar has inspired my thinking and that we have a great future if we can adapt to use this wonderful gift we receive from the sun. Many people do not understand that 1Kw of power is falling on every square meter of sunny ground in Australia every day. Every tomato, vegetable, grain and blade of grass that our food animals eat is solar powered. Using the sun to power my life has been fairly simple, I am a Net Energy Exporter, the power grid is a link to people and lives that I am happy to consider and support. I need a political solution to further help me distribute my energy to my threatened planet. Please try and help maybe a ten year plan?

There is no such thing as clean coal. Carbon Capture and Storage, even if it does work, will result in higher electricity prices. This is because the Carbon Capture technology doubles the price of the power station and 25-50% of the power produced is used in the Carbon Capture. This will double the price of electricity and is not one of the aims of government to produce electricity at a lower cost? How do I know all this? I worked in a power station which experimented in Carbon Capture. Also, Carbon Storage is far from being a proven technology.

It seems that many Liberal MPs and others are relying on Carbon Capture and Storage (CCS) to solve or at least play a significant part in Australia's energy requirements and emissions reduction in the future.

Where / how is it proposed to store the captured CO<sub>2</sub>? Has anyone done a calculation of the volume of CO<sub>2</sub> that would need to be stored?

Future government projections indicate that by 2050, there may be 26,000 Gigawatt/Hours of CCS generation (mostly coal, some gas) in the Australian energy market. My Origin Energy Bill shows that 1 KWh creates ~1.2 Kg of CO<sub>2</sub>, therefore 1GWh would produce ~1200 tonnes of CO<sub>2</sub>. And therefore 26,000 GWh in 2050 will produce (26,000 x 1200) = 31,200,000 tonnes.

Given that 1 cubic metre of CO<sub>2</sub> weighs ~ 1.8 Kg, then 31,200,000 tonnes would occupy ~17,333,333,000 cubic metres or 17,333,333 Megalitres (1 Megalitre = 1,000 cubic metres or 10 x 10 x 10 metres)

For comparison purposes: Sydney Harbour holds ~500,000 megalitres, and therefore 2050's CCS storage would require ~34 "Syd Harbs" of storage per year or 1 "Syd Harb" every 11 days.

If compression is involved, then pressure vessels capable of infinite storage time must be manufactured and energy used to compress the CO<sub>2</sub>...

If reaction with say Calcium to produce Calcium Carbonate is proposed then the storage time is short-term and will leak back into the atmosphere.

Please tell me that my calculations include at least a 1000x error, otherwise where will this new SECURE storage be found - every year?
