Options on local government funding crisis Roundtables in Hobart & Melbourne

A provocative discussion paper on options for local government financing has been released by the House of Representatives Economics Committee ahead of two days of roundtable discussions in Hobart and Melbourne.

The Committee is examining the financial position of local government, in particular the impact of cost-shifting. The 35-page discussion paper, titled '*At the crossroads*', identifies key issues presented to the inquiry so far, and outlines a range of options which the committee says could help address what the councils say is a funding 'crisis'.

The inquiry is examining local government's current roles and responsibilities, current and alternative funding arrangements, and the scope for achieving a rationalisation of roles and responsibilities between the levels of government.
