	Secretary:

- The District Council of Grant is situated in the south east corner of South Australia.
- The Council has a population of 8,500 and an area of 2,000 square kilometres.
- Total road length is 1,583 kilometres (sealed 423 kms and unsealed 1,160 kms) (Source South Australian Local Government Commission, June 2001 GIS database)
- Significant industries are dairying, forestry, fishing (rock lobster and abalone) and horticulture.
- Estimated gross value of production in 1999/2000 was \$664 M – excluding an additional \$300 M export income.

ROAD FUNDING

- Timber Industry expansion and harvesting will take place additional demands for upgrading of roads in the Region.
- The Timber Industry Roads Evaluation (TIRE) Study (October 1999, PPK Environment & Infrastructure) – Investment cost for the South East Region estimated at \$7.8M for period 1999 – 2008.
- Total investment cost in District Council of Grant is \$5.67 M or 73%.
- "By 2020, the total area under plantation will be around 180,000 hectares of which approximately 110,000 hectares will be under pinus radiata and 70,000 hectares will be under Blue Gums" (TIRE Study).
- Cost to MAINTAIN sealed road infrastructure for 2001/2002 in the District Council of Grant is \$666,000 increasing to \$923,000 in 2003/2004. (Road Transport Services - Five Year Management Plan 2000)
- Council only able to afford to allocate \$350,000 in 2001/2002 for resealing of existing roads.
- The State Government Regional Road Program was cut by \$1.5 M resulting in a total allocation for South Australia of \$700,000 for 2002/2003.
- The State Government Tourism Road Grant Program (\$545,000) was abolished in 2002/2003 budget.

ROAD FUNDING

- The Federal Government decreased the Roads to Recovery Program in 2002/2003 (reduction of \$75,000).
- The "Wealth of Opportunities Report" on Local Government Infrastructure Asset Management concluded that South Australian Councils need to increase expenditure on maintaining Road Assets from \$42 M to \$147 M per annum.
- The Federal Government collects 38.1 cents per litre from petrol and diesel and only 6 cents of every litre is spent nationally on Roads (\$1.8 B out of \$12 B). (Australian Automobile Association)

South Australia has the lowest identified Road Grant per capita or per kilometre due to the existing Financial Assistance Grants methodology for road funding.

- Identified Local Roads Grants are distributed on 'historical' not fiscal equalisation basis.
- In 2002/2003 the District Council of Grant was allocated \$763,868 General Purpose Grant and \$214,978 Local Road Grant (Total \$978,846).
- TOTAL SOUTH EAST Local Road Grant for 2002/2003 was \$1.709 M (estimated population around 62,000, estimated area 21,500 square kilometres).

• Council allocated \$2.1 M out of \$3.2 M General Rate Revenue in its 2002/2003 budget for Road Construction and Maintenance.

PROVISION OF AGED CARE SERVICES

Recognition of an increasing aging population and need for provision of capital funding for high and low care places.

- Estimated demand for high care places in Mount Gambier and District 30.
- Estimated demand for low care places in Mount Gambier and District 70.
- The District Council of Grant and City of Mount Gambier have provided in excess of \$1.15 M since 1995 for capital funding for Aged Care (City of Mount Gambier \$925,000 District Council of Grant \$225,000.
