## <u>Inquiry Into Averment Provisions in Customs Legislation -</u> <u>Further Submission on Behalf of Peter Tomson</u>

We refer to the recent telephone conversation between the writer and Dr Horne in relation to the reference in the Tomson trial transcript dated 20 April 1994 (page 6) to a document handed to Mr Parnell (Counsel for Mr Tomson).

We attach hereto the document we believe is the one referred to. It is the summary of the prosecutor's submissions in relation to the charges laid in respect of the Cameron Trading Co shipment.

To put the matter in perspective, please note that on page 3 of the transcript for 19 April 1994, reference is made to the fact that counsel addressed the Court. The addresses are not recorded. My recollection however is that Mr Parnell's address covered two matters, the first being the admissibility of certain averments in the form presented and the second being a submission that the charges in relation to the Cameron Trading Co shipment should be dismissed on the ground that the prosecution had not shown that there was a case to answer.

The address by Mr Lakatos (Counsel for the ACS) responded to Mr Parnell's submissions. My recollection is that Mr Lakatos, in making his address, referred as he proceeded to an *aide memoire* prepared for his use either by the ACS or his instructing AGS solicitor.

The hearing was adjourned following the addresses.

The magistrate opened the hearing the following morning by giving his ruling on the submissions relating to the averments (pages 1 to 4), and then turned to

the submissions relating to "no case to answer". He outlined the various categories of evidence referred to by the prosector, including the documentary evidence (pages 4 and 5) and the averments (page 5). He then gives his ruling (bottom of page 5 and top of page 6).

My recollection is that it was at that point that Mr Lakatos handed Mr Parnell the document referred to on page 6 of the transcript dated 6 April 1994. I believe that is the document attached to this note (the *aide memoire* referred to above). A glance through it reveals that the documents referred to in the magistrate's decision are the same documents referred to in the attachment. The document also refers to the fact that "The prosecution case relies on the averments contained in the informations ...".

I do not know who made the annotations on the document.
