Re Assault Diane Timothy 29 September 2000

I wish to add the following to my submission since the New South Wales Government supports the corrupt 'conciliation' report obtained by the Ombudsman from the same police officer, Hreszczuk, who was instrumental in covering up this crime.

I was duped by the Ombudsman who said --

1) 'The best way to deal with the matter is for a member of the Police Service to attempt to resolve the matter, the matter will be allocated to a suitably trained officer'.

NO ATTEMPT WAS MADE TO CONCILIATE THIS MATTER INSTEAD THE COVERUP CONTINUED. Inspector Hreszczuk, who was a major player in this coverup and who was the cause of my complaint to the Ombudsman contacted mc as that "suitably trained officer appointed to investigate himself in covering up this crime".

2) The Ombudsman states - 'The conciliation will involve the negotiation of mutually acceptable terms'.

There was no conciliation as I asked Hreszczuk 'what can be achieved by conciliation'. Hreszczuk replied 'nothing, as we have done as much as we can do'.

"IF YOU CONTINUE WITH THIS COMPLAINT YOU CAN BE CHARGED".

The Ombudsman states- 'If at anytime you are concerned about the manner in which your 3) complaint is being handled please contact me'

I contacted the Ombudsmans office and spoke with his representative, Greta McDonald, and informed her that Hrcszczuk was investigating himself and he threatened me and said 'if you continue with this complaint you can be charged'. The Ombudsmans representative advised me to write to the Ombudsman and to say you do not want anything more to do with this Police officer and we will look at it again. I followed these instructions in a letter to the Ombudsman dated 12 Jul 2001. THE OMBUDSMAN IGNORED MY REQUEST.

The Ombudsman then accepts and supports a corrupt report of a fictitious conciliation supplied by Inspector Hreszczuk stating 'Mrs Timothy was satisfied and agreeable to the outcome'. THE OMBUDSMAN KNEW THS REPORT WAS A FABRICATION. The Ombudsman was aware Hreszczuk was corrupt when he stated in CIS 01002509 Alternate Dispute Resolution Paragraph 16 'the tribula and agreeable to the outcome'. The Ombudsman was aware tribula and the tribule and the outcome. vehicle was not identified previously, that Sharp put an 'o' instead of a zero. The Ombudsman has admitted that the vehicle was identified previously by Sharp. The proof is in the RTA records.

The Ombudsman has legitimised this coverup and the New South Wales Government has endorsed
