RE: My Submission - Disability (Access to premises Building) Standards 2009.

Firstly and foremost, I wish to acknowledge, applaud and commend the efforts by all concerned in relation to the abovementioned, in bringing about change in order to improve "quality of life" for all those experiencing challenges in there day to day lives as a result of there disability.

With this in mind, I wish to share with you my extreme concerns I have in relation to accessing a very basic service within any public building or facility.

My brief background: I was born with a rare form of Muscular Dystrophy - "Bethlem Myopathy", and as with any disease with age, I have now experienced problem's within the community and as a result, I have become a PRISONER in my own home.

What is my problem? I cannot now leave my home as I have lost my security. Should I have the need to access a Toilet.

Yes! it is as basic as a Toilet!

Should I need to sit on the Toilet, because of my disability I am unable to propel myself up in order to get off. Even if I am within a "Disabled Toilet" the railing on the wall are of no benefit as I have severe wasting of the muscle's in my wrists so I'm unable to hold onto the rails and pull myself up.

What I would like to see as standard nationally and would solve my problem and others sharing the same difficulty is...

Very Simply install higher Toilet Suites

My 'Toilet Suite' at home is a CAROMA - PLN 614400W and sits on 4 cm's of concrete making the over-all height from floor to top of seat 47 cm's.

Simply having a higher "Toilet Suite" allows me the dignity of maintaining my own toilet needs.

Whom would be dis-advantaged by installing higher "Toilet-Suites" within ALL public toilets.

Simple answer: Absolutely No-one.
Having higher toilets will have no impact on able body person's what-so-ever however, improve the quality of life for person's such as myself.

There appears to be an attitude from my own perspective that by installing hand rails within "Disabled Toilet's" that all has been addressed.

* People such as myself fall through the cracks as we are not yet in a wheel-chair however as disabled as the person in the wheel-chair.

Being a person whom is totally comfortable with his disability and being totally realistic, I am fully aware and accepting of the fact that should I live long enough, I will be spending my awake hours in a wheel-chair. So, it is very important to me, to try despite the pain doing everything in my power to keep out of that wheel-chair.

What is worrying me is, because I can no longer get out of any community toilet even the designated disabled one's I cannot any longer leave home, which is going to impact on my emotional well-being more than my physical.

What I would like this enquiry to look at?

Seeing if it would be possible to include within the new standards nationally that any new installation of a "Toilet Suite" to be of the one I outlined earlier "CAROMA" Care Pan P/N 614400W and with current suites exempt unless for many reason's it needs replacing.

If Is amazing that when we look at how to improve One's "quality of life" you cannot get as basic as a "Toilet Suite". we are not talking about moving a mountain or big dollar's. A Simple "Toilet Suite".

I would like to See the end of low Toilet Suite's as not only person's with mobility limitation's have difficulties getting off a low toilet seat, a large no of our SENIOR (Eidely) Population also have lost the muscle strength in the tops of their legs which allow us to lift off a seat, chair etc.

So, In closing , as I stated earlier, my proposal can only Improve the "Quality of life" for people such as myself with mobility limitations and the elderly however makes No difference what so ever to any One else Using the "Toilet Suite".

This would allow me to retain my Independance, pride, dignity, self-respect but most importantly allow me to be part of Society again.

Thankyou for hearing my Viewpoint. I wish all Involved all the best and I only hope that my proposal be looked at or installed when looking at changes to the Current Standards.
