## **Environment, Communications and the Arts Legislation Committee**

**Portfolios allocated:** Broadband, Communications, and the Digital Economy; Climate Change and Energy Efficiency; Environment, Water, Heritage and the Arts For <u>current information</u> about the committee's hearings
