The Senate extended the reporting date for the inquiry of the Economics References Committee into the Australian dairy industry to 13 May 2010.

The Senate varied the resolution of the Senate appointing the National Broadband Network Select Committee by omitting the reporting date of "30 April 2010" and substituting "12 May 2010".
