Senator Carr gave a notice of motion to require the Minister representing the Minister for Education, Training and Youth Affairs to table draft guidelines on the calculation of SES scores and certain SES scores (no later than immediately after question time on the next day of sitting, ie. 28 August 2000)

Questions on notice-failure to provide answers

- □ Senator Ray asked the Minister representing the Minister for Health and Aged Care for an explanation why an answer had not been provided to a question about entertainment expenses. An explanation was not provided and the Senate agreed to a motion noting the Minister's failure to provide an answer.
- □ Senator Ray also asked the Assistant Treasurer for an explanation why answers had not been provided to questions about the provision of the electronic version of the electronal roll to the Australian Taxation Office. The Assistant Treasurer indicated that answers would be provided.
