Death of former Governor-General

The President informed the Senate of the death, on 8 December 2011, of the Right Honourable Sir Zelman Cowen, AK, GCMG, GCVO, QC, Governor-General from 1977 to 1982. A <u>motion</u> moved by the Leader of the Government in the Senate (Senator Evans) was carried [<u>first speaker</u>].

Diamond jubilee anniversary of Her Majesty Queen Elizabeth II

The President informed the Senate that 6 February 2012 marked the diamond jubilee anniversary of Her Majesty Queen Elizabeth II. A <u>motion</u> moved by the Leader of the Government in the Senate (Senator Evans) for an address to Her Majesty the Queen was debated and agreed to [first speaker].

Dissent from ruling

The Senate debated a motion moved by the Leader of the Australian Greens (Senator Bob Brown) objecting to a ruling of the President on 25 November 2011 (that the motion to refer a matter to the Privileges Committee not be given precedence) [debate on the motion will continue on 8 February 2012].

Proposed suspension of standing orders

The Senate debated but did not agree to a proposed suspension of standing orders moved by Senator Cormann to enable debate on a motion relating to the Government's failure to comply with orders of the Senate for the production of documents concerning the Mineral Resource Rent Tax [first speaker].
