Death of Australian Defence Force Personnel

The Leader of the Government in the Senate (Senator Evans) <u>moved</u> that the Senate records its deep sorrow at the death of Sergeant Brett Wood, MG, Lance Corporal Andrew Gordon Jones, Lieutenant Marcus Sean Case and Sapper Rowan Jaie Robinson while on combat operations in Afghanistan. The motion was carried.

Death of former senator

The President informed the Senate of the death on, 14 May 2011, of Andrew Murray Thomas, a senator for the state of Western Australia from 1975 to 1983. A <u>motion</u> moved by the Leader of the Government in the Senate (Senator Evans) was carried [first speaker].

Death of former member

The President informed the Senate of the death, on 22 May 2011, of the Honourable Ralph James Dunnet Hunt, AO, a former minister and member of the House of Representatives for the division of Gwydir from 1969 to 1989. A motion moved by the Leader of the Government in the Senate (Senator Evans) was carried [first speaker].

Statement by the President
