Request for information from the Joint Standing Committee on Electoral Matters

I write regarding your letter dated 24 February 2012 in which you sought information on behalf of the Australian Parliament's Joint Standing committee on Electoral Matters (JSCEM) relating to the New South Wales Electoral Commission's (NSWEC) Smartroll program.

I provide the following information regarding the SmartRoll program.

NSW State District of Clarence By-election – September 2011

By-election events are often used to test new procedures prior to their introduction across the State.

The 2011 resignation of the sitting LA member for the NSW District of Clarence provided just such an opportunity, particularly as the full "enrolment and vote" provisions – for both enrolment new and enrolment transfer voting - of the *Parliamentary Electorates and Elections Act* were newly in force. In order to minimise any potentially disruptive "enrolment and vote" processes in polling places on Clarence election day, it was decided to conduct a Clarence District enhanced SmartRoll enrolment process prior to that event.

The enhanced enrolment procedures included:

- a) Enrolment transfers capturing all electors' movement into, out of and within the Clarence District and implementing those enrolment changes; and
- b) Enrolment new broadening the SmartRoll candidate selection process to include potentially eligible but unenrolled new electors that had been sourced from RTA data sources. This was deemed to be the best elector data source to enrol those who were eligible to be enrolled but had not enrolled. These were the so-called "missing" electors.

The result of the enhanced enrolment was that enrolled elector numbers increased from 50,276 in August 2011 to 52,256, an increase of 3.9% with almost 1,874 of those being newly enrolled electors.

<u>Clarence – The Impact of Enhanced Enrolment Procedures on the September 2012</u> LGE Rolls The success of the Clarence enhanced enrolment process prompted a discussion on the need for the following questions to be answered:

- 1. Was the enrolment improvement likely to be relatively uniform across different demographic and/or geographic regions?
- 2. If it was, what was the likely impact of a whole-of-State enhanced enrolment process?
- 3. Could such a State-wide program be completed for all of NSW before the September 2012 Local Government Elections?

In order to answer question 1 above, further pilot areas were conducted in both metropolitan and regional areas, both State and local government based. Given that Clarence was a regional coastal area, the further pilot areas were regional inland (Wagga Wagga State District), metro coastal (Pittwater State District) and metro inland (Canada Bay LGA).

I note that the new enrolment levels and results were pleasing as they allowed for a whole-of-State analysis. This indicated that an improvement in enrolment levels of between 3% and 4% (ie 140,000 to 180,000 "missing" electors) was likely to be achieved by using an enhanced SmartRoll program.

SmartRoll – The Enhanced Enrolment Program for the September 2012 LGE

Planning analyses were conducted indicating that an enhanced SmartRoll enrolment program could be conducted prior to the NSW LGE.

This program is in place and is being conducted at a rate of 15,000 per week. This is made up of:

- Approximately 500 enrolment transfers; and
- Approximately 10,000 enrolment new SmartRoll candidates.

I trust the above information is of assistance.
