(2) Source: National Hospital Cost Data Collection, Round 12 (2007-08), national public and private sector cost weights V5.1

(3) Separations for which the care type was reported as *Newborn* with no qualified days, and records for *Hospital boarders* and *Posthumous organ procurement* have been excluded.

(4) Includes separations with a Major Diagnostic Category (MDC) of 22: Burns. MDC 22 includes AR-DRG codes Y01Z-Y62B. Note that AR-DRG figures may differ slightly to those published by the Australian Institute of Health and Welfare due to the use of different grouper software.

(5) Total estimated costs were calculated by applying the AR-DRG version 5.1 2007-08 national public and private sector estimated average costs (NHCDR R12) to the AR-DRG version 5.1 data for 2007-08. The average costs are estimated based on expenditure by hospitals.
