## Strata insurance increases spark widespread community concern – upcoming public hearings in North Queensland

The House of Representatives Standing Committee on Social Policy and Legal Affairs has been overwhelmed with the response to its inquiry into residential strata title insurance. The Committee has authorised more than 380 submissions for publication, with more to be added to the inquiry website in the coming weeks.

Committee Chair Graham Perrett MP said he appreciated the time and effort so many people had taken to alert the Committee to their concerns.

"I have been shocked by the scale of some of the insurance premium increases and I know the Committee is keen to gather more evidence on this concerning issue during the hearings in North Queensland," he said.

The Committee's hearings in Port Douglas and Cairns on Monday 30 January and in Townsville on Wednesday 1 February have also generated strong interest, with full hearing programs taking in a range of industry and community representatives. The Committee will be holding an insurance industry roundtable during the Cairns hearing with the Insurance Council of Australia. The hearings will close with half hour public forums, which will provide members of the public the opportunity to voice their concerns.
