Coastal representatives attend Sydney hearing

The House of Representatives Climate Change, Water, Environment and the Arts Committee will hear from a range of organisations and individuals at a public hearing in Sydney on Wednesday, 25 March and Thursday, 26 March 2009 as part of its inquiry into climate change and environmental impacts on Australia's coastal zone.

Those appearing before the Committee include the NSW Government; the National Sea Change Taskforce and other local government groups; the Insurance Council of Australia; the Australian Conservation Foundation and other environmental groups; the Australian Network of Environmental Defender's Offices; industry representatives; and leading coastal researchers, including Professor Bruce Thom and Professor Colin Woodroffe.

"The NSW Government recently released its draft sea level rise policy and planning benchmarks," Committee Chair Ms George said.

"The Committee will be interested to discuss the implications of this draft policy and other matters with those attending the hearing."
