Inquiry into the current and future directions of Australia's service export industries

In response to your previous communication, the Australian Vice-Chancellors' Committee (AVCC) is pleased to make a submission to the inquiry into the current and future directions of Australia's service export industries.

Having had the opportunity to review the previous departmental and industry submissions to the inquiry, the AVCC endorses the information previously supplied by our university members and the Department of Education, Science and Training.

Further to this, and in response to a point raised in one of the education related submissions, the AVCC would like to caution against an overly strong link or pathway between study and permanent residency. While it is acknowledged that many international students come to study in Australia with the specific objective of obtaining permanent residency on completing their academic qualification, there are a number of reasons why the international education industry does not explicitly link education and migration when marketing Australian education opportunities. These reasons include:

- Institutions from overseas collaborate with Australian universities as a result of the outstanding reputation the university sector has developed for high quality teaching and research. As the Federal Government has recognised, it is important that the university sector's reputation for quality is safeguarded and promoted internationally. Any suggestion that the Australian education system is influenced by the domestic immigration agenda may damage the industry's international positioning and limit the opportunities that Australian universities have to collaborate internationally in teaching and research;
- closely aligning immigration policy with university recruiting initiatives may lead to a comparatively
 narrow nationality mix of international students. This would be inconsistent with the Australian
 higher education sector, which strives to operate in a truly global context. Any narrowing of the
 sector's teaching and research profile would negatively impact on the perception of the Australian
 education industry's integrity within the international domain. Universities seek greater diversity in
 their student population than just those professions on the Migration Occupation in Demand List
 (MODL);

- concerns have been raised by overseas governments regarding Australia actively targeting their best students for migration. Therefore, it is not appropriate for universities to actively market themselves as conduits for permanent migration; and
- migration is an optional, and personal, outcome for a small percentage of graduating international students and therefore migration, and the process of achieving this, is not an educational policy issue for universities.
