Thank you for copies of the transcript of evidence given on 21 September 2006 in the Legislative Council Committee Office in Perth, Western Australia. We were most appreciative of the comments made by Chair, Mr Peter Lindsay MP, on behlaf of the Joint Standing Committee on Electoral Matters, concerning the quality of the submission (for Jane Gray) and commitment to civic education (for Harry Phillips).

During the course of giving evidence we were both asked to amplify our views concering the civic education of migrants. We have discussed this important issue and suggest consideration of the following steps:

* A civic induction program should be offered fo all immigrants during the period that is required for them to satisfy residency requirments;

* For the conveninece of the migrants the induction program, of about two full days in duration, should be offered according to a number of formats suh as two full days, mornings or afternoons or evenings;

* The timing of the program would be be subject to the immigrant acquring some proficiency in English. Versions in other languages should be produced as deemed beneficail. Our view is that a certificate of 'civic participation' would be a component of citizenship requirments. A small booklet, modeled on Harry Phillips, A Citizen's Guide to the Western Australian Parliament (2006), adapted to an Australia wide perspective with more emphasis on electoral enrolment provisions, should be provided to the prospective citizens. Booklets prepared for citizenship activities (and tests) in the United Kingdom, Canada, and the United States of America should be consulted. Publications should probably be the responsibility of the Department of Immigration of Immigration and Multi-Cultural Affairs.

The induction course would also provide participants with suitable and interesting video or DVD materials;

* A minimum level of proficiency should be encouraged but not made mandatory, particularly as Australian citizens are not required to meet minimum standards and: *The civic participation courses could be conducted by TAFE institutions. In Western Australia the Constitutional Centre would be an appropriate agency.

In making this requested supplementary submission we would like to indicate our strong support for a recoomendation included in the recently published Voices and Votes Report of the Queensland Parliamentary Committee Inquiry into Young People Engaging in Democracy (2006). In part the Committee (p. 110) stated:

"the committee recommends that the Minister for Education conduct a longitudinal study of the effects of the implementation of the Active Democarcy recommended in this report. The longitudinal study should be based on the Citizenship Education Longitudinal Study undertaken in the United Kingdom by the National Foundation for Educational Reserach.

In essence we are recommending the conduct of a political socilaisation research project for Australian youth. An endorsement of such a project by your committee would facilitate the conduct of such vital research.

If futher information is required we would be most willing to comply.
