Parliament of Australia Joint Standing Committee on Electoral Matters

ELECTORAL INTEGRITY HEARING TO TOWNSVILLE AND SYDNEY

The Electoral Matters Committee will resume hearings at the end of this month in Townsville and Sydney.

At its public hearing in Townsville on 29 January the Committee will hear from former MHR Brian Courtice, former ALP Returning Officer Ray Muller (subject to Mr Muller's good health), former ALP pre-selection candidate Terry Gillman, Mayor of Townsville Tony Mooney, federal MP Peter Lindsay and Liberal Party campaign team member Bruce Bellette.

The Committee will then move to Sydney on 30 January to take evidence from Lee Bermingham, Nicholas Berman and Steve Simat, and Dr Amy McGrath.

Committee Chair, Mr Christopher Pyne MP (Member for Sturt) emphasised that the inquiry is not about the internal party matters of political parties but is targeted at the identification of fraudulent enrolment practices. 'The Committee's primary term of reference for this inquiry is to place evidence of fraudulent enrolment on the public record and develop a basis from which to recommend appropriate legislative changes that will protect the integrity of the roll. As the country will see a number of elections in the federal and state sphere this year, the urgency of identifying measures to curb electoral enrolment fraud and restoring public confidence in the electoral system is great,' he said.

'The Townsville witnesses should be able to shed light on enrolment fraud and the factors leading to it', said Mr Pyne. 'Mr Courtice, former MHR for Hinkler, has made public allegations about irregularities in AWU elections and has called for reform of industrial relations legislation to curb union influence. Mr Muller's reports of enrolment fraud drew criticism from ALP figures Mike Kaiser and Joan Budd. Mr Gillman is the candidate defeated by Karen Ehrmann in the 1996 Thuringowa pre-selection. The ALP pre-selection for the state seat of Townsville, which Tony Mooney contested, has been the subject of allegations of enrolment fraud'.

The first Sydney witness will be Lee Bermingham, former ALP State Organiser whose claims of activities relating to enrolment fraud have attracted widespread attention. Dr Amy McGrath, who will also appear in Sydney, is a strong advocate for greater transparency in the electoral system and a critic of the Australian Electoral Commission. Nicholas Berman and Steve Simat are have been the subject of allegations of false enrolment.

'The hearing provides the Committee with an opportunity to obtain concrete evidence of fraudulent activity and to explore avenues of reform with witnesses whom we consider are critical to our inquiry', said Mr Pyne.

INQUIRY INTO THE INTEGRITY OF THE ELECTORAL ROLL
