# **FOURTH SUBMISSION TO THE JSCEM 2004 FEDERAL ELECTION INQUIRY**

## **Introduction**

This is the fourth submission by the Australian Electoral Commission (AEC) to the Joint Standing Committee on Electoral Matters' (JSCEM's) inquiry into the conduct of the 2004 federal election.

This submission provides responses to requests for information, documentation and statistics that were either taken on notice or requested of AEC staff during the Tweed Heads hearing in the division of Richmond on 7 July 2005.



## **Page 52: Handling of LFF complaints on polling day**

---

*Senator Brandis requested that the AEC provide a detailed timeframe of the handling of complaints in relation to the liberals for forests on polling day.*

Response:

The timeline for the handling of the complaints on 9 October 2004 in relation to liberals for forests is set out below. As an introductory matter, the AEC refers the JSCEM to the AEC's complaints protocol (at Attachment D), in accordance with which complaints throughout the 2004 federal election period that alleged a breach of the Electoral Act were dealt with. This protocol was distributed to all major political parties and was made available on the Australian Electoral Commission's internet website, [www.aec.gov.au](http://www.aec.gov.au).

### **National Party complaints handling on 9 October 2004:**

- DRO Richmond forwarded a complaint from Mr James Lantry, Campaign Manager for Larry Anthony to NSWWHO regarding the distribution of a LFF how-to-vote (HTV) card. The fax was received by NSWWHO at 10:11. This complaint was then forwarded to the AEC's Central Office (CO) by email at 10:42 for action and is attached at E1. A colour copy of the HTV was not received in CO on election day.
- As a registered political party, LFF is entitled to use its party name in political advertising. The AEC concluded that the HTV card was not in breach of s 329. The card was clearly marked "liberals for forests" on six occasions and the party identification of the LFF candidate was correct and not misleading. DRO Richmond was advised of the AEC's decision by email at 10:58. This advice to DRO Richmond is attached at E2.
- The advice to DRO Richmond also noted that "Liberals for forests should not use words "vote Liberal" or "vote for the Liberals"." The basis upon which this advice was given is not recorded in that advice. However, it is possible that at the time the advice was given, it was thought that the use of such words may render an otherwise compliant how-to-vote card in breach of s 329, although this view was rejected by subsequent legal advice (set out below).
- In response to the advice from CO, DRO Richmond contacted the Officers in Charge (OICs) of the Polling Places nominated by the complainant as having lff party workers and the Polling Place Liaison Officers (PPLOs) directing them to advise the party workers of the decision.
- The AEC received a faxed complaint, at 13:07, from Mr Andrew Hall, Federal Director of the National Party, regarding the same LFF HTV card for Richmond and a similarly formatted HTV card for the division of Page. This complaint is attached at E3.

- Mr Hall was contacted by telephone and advised that the HTV card was not in breach of s 329 shortly after receipt of the complaint. The exact time is not recorded.
- NSWHO received a fax, at 13:48, from DRO Richmond forwarding a further complaint from Mr James Lantry, regarding the distribution of an electoral advertisement titled "Why Larry has to go". The advertisement was forwarded to the AEC for action shortly after. The complaint is attached at E4.
- A review of the advertisement indicated that it was in technical breach of the CEA. The advertisement was improperly authorised as it provided a PO Box rather than a street address as required by the CEA. The AEC CO advised DRO Richmond, at 15:01, that the officer in charge should be advised that the leaflet must be either withdrawn from distribution or amended to comply. Mr Lantry was also contacted by telephone and advised of the AEC's decision. Email correspondence regarding this course of action is attached at E5.
- On receipt of the advice from CO, Richmond divisional staff telephoned OICs and PPLOs to advise that the leaflet had to be withdrawn until properly amended.
- NSWHO received a fax, at 16:57, from DRO Richmond regarding the employment of overseas visitors without working visas. This matter was forwarded shortly afterwards to AEC CO for action. This complaint is attached at E6.
- AEC CO contacted Mr James Lantry by telephone and advised that this was not an issue that fell within the scope of the CEA.
- The AEC subsequently wrote to Mr Andrew Hall, Federal Director of the National Party on 14 October 2004 to confirm the AEC's oral advice on 9 October 2004. A copy of the AEC's response is attached at E7.

**Liberal Party of Australia complaints in relation to the liberals for forests  
(s 327 and s 329) 9 October 2004:**

- At 10:38 on 9 October the AEC received a facsimile from Scott Morrison, NSW State Director, Liberal Party of Australia, concerning potential breaches of ss 327 and 329 of the CEA. The complaint concerned the LFF's how-to-vote (HTV) card, T-shirts worn by LFF party workers and emphasis of the word "liberals" when handing out HTV material in the Division of Parramatta and Greenway. Copies of HTV cards did not accompany this complaint. A copy of the complaint is attached at E8.
- The AEC received a further facsimile from Mr Morrison at 11:12 providing further information in relation to the initial complaint. A copy of the Liberal Party of Australia HTV card and liberals for forests HTV card was faxed to AEC CO with this complaint. A colour copy of the complaint was not sent to the AEC on election day. However, the complaint made reference to the colours displayed on the HTV card. This facsimile is attached at E9.

- The AEC advised Mr Morrison of its determination through Mr Bede Fennell by email at 12:06. Mr Fennell was advised that the LFF HTV card was not in breach of s 329. LFF is a registered political party and as such is entitled to use its party name in political advertising. The HTV card was clearly marked “liberals for forests” on six occasions and the party identification of the LFF candidate was correct and not misleading. Mr Fennell was also advised, in accordance with Senior Counsel advice (referred to below and attached at E4) that the use of the words “vote liberal” or “here’s how to vote Liberal” would not fall within the scope of s 329 nor render an otherwise compliant HTV card misleading.
- Mr Fennell was also advised that no assessment could be made of the LFF T-shirts as no copy or photograph had been provided.
- Mr Fennell wrote to the AEC at 12:13 by email requesting an AEC view with respect to s 327.
- The AEC sought legal advice from the Australian Government Solicitor (AGS) on the potential application of s 327 to the circumstances.
- After consideration of the AGS’s legal advice and relevant case law (see *re Carroll v Electoral Commission of Queensland & Reeves* [1998] QSC 190 at par [135] per Mackenzie J) the AEC was of the view that no breach of s 327 was disclosed. The card in question was not a second preference HTV card, and there was insufficient factual evidence.
- Mr Fennell was advised of the AEC’s determination by email at 12:45. A copy of the email interchange between the AEC and Mr Fennell is attached at E10.
- AGS’s legal advice to the AEC was subsequently confirmed in writing by Senior Counsel at 13:02. Senior Counsel’s confirmation is attached at E11.

## **Page 53: LFF complaints decision maker**

## **Page 50: 'Transit' voters**

---

*Mr Danby requested that the AEC provide details of the numbers of voters that 'transit' through the electorate.*

Response:

As at the Close of Rolls for the 2001 federal election there were 80,803 electors eligible to vote in the division of Richmond. The number of electors eligible to vote in the 2004 federal election increased to 85,666. This represents an increase of just over six percent (6.02%).

Neighbouring divisions provide useful comparisons to these figures. The division of Cowper experienced an increase of 6.14%, from 79,363 in 2001 to 84,235 in 2004. The division of Page increased by 3.15% in the same period, from 81,721 to 84,292.

***Commonwealth Electoral Act 1918 – election day complaints – confirmation of advice***

I refer to three complaints The Nationals lodged with the Australian Electoral Commission (AEC) on polling day, 9 October 2004. Two of the complaints concerned liberals for forests (LFF) and one concerned electoral matter that had not been properly authorised. Each of the complaints concerned the Division of Richmond in New South Wales, though one of the complaints concerned the Division of Richmond and the Division of Page. As you would be aware, the AEC provided oral responses to each of the complaints on Saturday 9 October 2004. This letter provides written confirmation of those responses.

Each of the complaints was assessed in accordance with the requirements prescribed in the *Commonwealth Electoral Act 1918* (the CEA) and, where relevant, in light of judicial consideration of specific provisions.

**Complaint 1: LFF how-to-vote cards**

The first complaint related to the LFF how-to-vote (HTV) card. The substance of the complaint was that the card breached s 329 of the CEA as it deceived people into believing that the card was from a different registered political party – the Liberal Party. A facsimile copy of the HTV card is attached at ‘A’ for your reference (the HTV card forwarded to the AEC was a HTV card for the Division of Page).

The AEC assessed the card in light of the requirements of s 329, judicial consideration of s 329, and previous advice from the Commonwealth Director of Public Prosecutions (DPP). The AEC determined that the card was clearly a LFF HTV card. The card carries the title: “HOW TO VOTE LIBERALS FOR FORESTS”. While the word “LIBERALS” is the most prominent word on the HTV card, the words “FOR FORESTS” are as large as “HOW TO”. Further, the representation of the House of Representatives and Senate ballot papers clearly indicate the party affiliation of the candidate representing LFF.

Despite the fact that the layout and colour of the HTV card was similar to the Liberal Party’s HTV card, a summary review of the card clearly indicates that the card was issued by LFF, not the Liberal Party.

It is worth noting that liberals for forests is a registered political party under Part XI of the CEA. While the AEC made a decision pursuant to s 129(d) to refuse the application for registration of the party name "liberals for forests" on the basis that the name 'so nearly resembles the name...of another political party...that it is likely to be confused with or mistaken for that name or that abbreviation or acronym', that decision was set aside by Justices Gray, French and Nicholson in the Administrative Appeals Tribunal on 6 March 2001 (see Woollard and Australian Electoral Commission and Liberal party of Australia (WA Division) Inc [2001] AATA 166 (6 March 2001)).

Liberals for forests are a registered political party under the CEA, issued a HTV card bearing the registered name of the party, and indicated the party affiliation of the LFF candidates. Consequently, the HTV card did not breach s 329.

### **Complaint 2: Improper authorisation of electoral matter**

The second complaint was lodged by Mr James Lantry, campaign manager for Mr Larry Anthony MP. This complaint concerned a handbill titled: "Why Larry has to go". The substance of the complaint was that the handbill was not properly authorised in accordance with s 328(1)(a) and (b) of the CEA. A copy of the handbill is attached at 'B' for your reference.

The AEC determined that the handbill did not comply with s 328 and requested all Officers in Charge of polling booths in Richmond to bring the matter to the attention to those responsible for the distribution of the handbill. Officers were asked to convey to the relevant people that amendments to the address and printer details on the advertisement were required to ensure compliance with the CEA. This was coordinated by the Divisional Returning Officer.

The AEC had no way of identifying "M Balson" (the authoriser of the handbill) on polling day. However, the AEC has written to Mr Balson advising him of the requirements of the CEA with respect to the authorisation of electoral matter.

### **Complaint 3: Visa status of LFF booth workers**

The third complaint was lodged by Mr Lantry and concerned the visa status of LFF polling booth personnel. Mr Lantry alleged that LFF polling booth workers were "employed" by LFF in contravention of the visa status of the persons concerned. Mr Lantry did not identify any particular person nor did he provide the AEC with any factual evidence to substantiate the complaint.

Mr Lantry was advised that the visa status of persons involved in the distribution of electoral matter was not a matter that arose for consideration by the AEC. Mr Lantry was advised to address any concerns he had about the visa status of people within Australia to the Department of Immigration, Multicultural and Indigenous Affairs.

AEC Election Day complaints protocol

**Electoral Update No. 3 - 3 September 2004****Handling of election complaints**

The AEC will be following the protocol set out below in relation to complaints received from individuals and organisation alleging breaches of the Commonwealth Electoral Act. The relevant parts of the Commonwealth Electoral Act are also set out below for information. The full text of the Electoral Act can be accessed [here](#).

Polling day for the ACT Legislative Assembly election is due to be held on Saturday 16 October. It should be noted that section 328 of the Commonwealth Electoral Act applies to all material containing electoral matter, including campaign publications associated with the ACT election.

**PROTOCOL FOR THE INVESTIGATION OF COMPLAINTS DURING A FEDERAL ELECTION REGARDING POSSIBLE BREACHES OF THE COMMONWEALTH ELECTORAL ACT 1918**

The most common complaints received by the Australian Electoral Commission (AEC) at election time concern possible breaches of ss 328, 329 and 331 (see attached) of the *Commonwealth Electoral Act 1918* (CEA).

Section 328 deals with the need to identify the person who takes responsibility for an electoral advertisement, section 329 covers the content of such advertisements where they may mislead or deceive the reader and section 331 places responsibilities on publishers to ensure that an advertisement is clearly that - an advertisement.

While this document relates to the process adopted by the AEC during investigations of complaints under these sections, in the course of those enquiries other matters may be disclosed warranting further consideration. In any event the following protocol will be applied.

**The Protocol**

The AEC will exercise its discretion in the operation of this protocol, commensurate with its obligations under Part XXI of the CEA.

Information relevant to a complaint, allegation or investigation that is, or could become, subject to Part XXI proceedings, will not be provided to any person not directly involved with the matter.

Complaints must be made in writing addressed to the Electoral Commissioner and be accompanied by original examples of the material in question; e.g. a How-To-Vote card or other electoral advertisement. This provides the context for preliminary assessment of the advertisement and also enables it to be tendered in court if proceedings are undertaken at a later date. The complainant should also provide as much additional information as possible to enable assessment of the alleged breach.

If the AEC has any doubt as to whether the material contravenes the CEA, the material will be referred to the Commonwealth Director of Public Prosecutions for advice. (*Note: The DPP will deal with the matter expeditiously, but it may take two or three business days for the DPP to give the matter the appropriate consideration.*)

If on the DPP's advice the AEC forms a *prima facie* view that whilst s 328 may have been contravened, the material is attributable to a person who takes responsibility for its content and/or its printing, and if that person is prepared forthwith to withdraw it from circulation or amend it to comply with the legislation, no further action will be taken by the AEC. There is no public interest to be served by pursuing 'letter of the law compliance' when the 'mischief' the legislation is designed to address, has not occurred.

If a publisher fails to comply with the requirements of s 331 of the CEA, the AEC will treat a complaint under this section in the same manner as above in the event of a technical breach. If it is a technical breach no action will be taken other than to advise the publisher of the need to comply with the legislation and that further breaches may involve prosecution.

Complaints relating to s 329 of the CEA are not likely to involve technical breaches in the above sense. Consequently, all

complaints concerning s 329 require immediate action. If after preliminary consideration by the AEC the offending material is not withdrawn or amended immediately, injunction action may be taken by the AEC in accordance with s 383 of the CEA. (*Note: Injunctive action may also be taken by a candidate in the election pursuant to section 383*)

With any complaint, where preliminary advice to the AEC indicates a substantial breach of the legislation, the AEC will refer the matter to the Australian Federal Police (AFP). Following completion of the AFP's enquiries the AEC will determine what, if any, further action is required.

In all cases after a complaint has been laid, the AEC will not provide any further information to the complainant until the investigating authorities advise the AEC that it is appropriate to do so. When appropriate the AEC will write to the complainant advising of its decision and actions.


