Public hearings in Melbourne to inquire into the 2007 federal election

The Joint Standing Committee on Electoral Matters will hold public hearings in Melbourne on Monday 11 and Tuesday 12 August 2008 as part of its inquiry into the conduct of the 2007 election.

"The Committee will hear from a range of witnesses including the Australian Electoral Commission State Managers for Victoria and Tasmania, academics with an interest in political party financing and electronic voting as well as groups representing homeless people," Committee Chair Daryl Melham said.

More than 3.4 million Victorians were on the electoral roll for the 2007 Federal election, an increase of almost 149,700 (4.5 per cent) compared to the election in 2004. The rate of "early voting" in Victoria increased 49 per cent at the 2007 election compared to 2004.

Submissions to the inquiry have highlighted a number of issues relating to the election and the electoral system including:

- the increase in "early voting"
- concerns over informal voting
- the success of electronic voting trials for the vision impaired and overseas defence force personnel
- the impact of recent changes to electoral laws on enrolment and provisional voting
- concerns over recent changes to political finance and disclosure arrangements.

The venue for the hearings is the Legislative Council Committee Room, Parliament of Victoria, Spring St, Melbourne. The hearings commence at 9.15am and are open to the public. They will also be webcast (audio only) live on http://webcast.aph.gov.au/livebroadcasting/.
