# ELECTORAL MATTERS COMMITTEE TO DISCUSS POLITICAL DONATIONS WITH AEC

The Australian Electoral Commission (AEC) will appear before the Electoral Matter Committee tomorrow (25 September 2001). This will be the AEC's first appearance since it revealed it has serious concerns about the operation of the electoral funding and disclosure scheme.

In its latest submission to the Committee's inquiry into funding and disclosure, the AEC argues that, amongst other things, donors and political parties may be disregarding the intent of the scheme by either minimising or avoiding disclosure.

The Committee Chair, Mr Christopher Pyne MP, Member for Sturt commented that 'the AEC has made it clear that it believes the funding and disclosure scheme is not working properly.'

The possible loopholes identified by the AEC include: using trusts and foundations to hide donors; channelling donations through fundraising organisations; donations sourced from overseas; and donating to MPs between elections.

'Such loopholes diminish the intent of the funding and disclosure scheme, which is to provide the public with a transparent view of who is funding Australia's political parties, ' Mr Pyne said.

'The AEC is recommending extensive changes to the funding and disclosure scheme, including an overall ban on all disclosure avoidance mechanisms, and ensuring that political parties are held responsible for inaccuracies in their disclosures,' Mr Pyne continued.

'The Committee will work through these issues with the AEC in the interests of ensuring a transparent disclosure scheme in the future,' Mr Pyne concluded.
