A Charter for Sustainable Australian Cities Sydney, Tuesday 8 June 2004

A Charter for Sustainable Australian Cities will be one of the proposals discussed by the House of Representatives Environment Committee at a public hearing in Sydney on Tuesday, 8 June 2004.

A number of witnesses are appearing before the Environment Committee including: representatives from Middle Way consulting, the Warren Centre for Advanced Engineering, the Faculty of the Built Environment at the University of New South Wales, the Australian Water Association, Origin Energy, the Railway Technical Society of Australasia, the Housing Industry Association and the Planning Institute of Australia.

To ensure that Australian cities of the future are clean, liveable and accessible places, the Environment Committee is conducting an inquiry into *Sustainable Cities 2025*. The inquiry began late last year with the issuing of a 20-page discussion paper. This is the twelfth public hearing for the inquiry.

The *Sustainable Cities 2025* inquiry is looking at developing a national blueprint and set of objectives for sustainable Australian cities. A key issue is the type of governance structures and policies needed to achieve this, and how the three tiers of government can cooperatively work towards sustainability in our metropolitan areas.

"Integrating the built and natural environment in a sustainable manner requires planning and a clearly articulated strategy," said the Environment Committee Chair, Mr Bruce Billson MP. "Identifying the issues and articulating a forward strategy for the nation is the target of this inquiry".

A Charter for Sustainable Australian Cities is a proposal put forward by the Planning Institute of Australia. A Charter would coordinate Commonwealth, State and Territory interests as they relate to urban development, and possibly set out sustainable development targets and milestones.
