Australia faces the major challenge over the 2010-20 period of having to satisfy the increase in demand for housing from a growing population.

Unlike other countries that experienced an oversupply of housing during the mic 2000's, Australia finds itself in a unique position of an already tight housing market with limited spare capacity to increase supply.

With skills constraints to continue, housing affordability is set to decline setting a course towards higher home prices as Australia's housing stock fails to keep pace with population growth.

Two key factors will, over the next decade further exacerbate efforts to increase nousing supply and affordability - skilled labour shortages caused in part through the transition of the ageing workforce into retirement and the skills needs of a strong resources sector. For the purpose of this response HIA is in an ongoing progression or research and analysis to consider the shortfalls broadly and then consider the implications of the resource sector skills needs.

Our concerns also relate around supply and demand factors in the regions which is shown in the supporting graph;
