[iii] Does the existing formulae work?

- 1. In my experience NO, the formulae en-actioned by the child Support Agency has been totally one sided. And the following facts are still in existence.
- 2. The Child Support Agency Methods are severely lacking in professionalism, and accuracy, in their entirety
- 3. At no time has the agency recognised the method I and my ex-wife arc attempting to operate for the care of **Weighter 1** which is a verbal 50/50 system until we can get my custody application heard before the magistrate, in this instance we would have all been better off if the Agency had **Not Intervened**.
- 4. At no time has any of my parenting skills or rights been taken into account by the Child Support Agency
- 5. At no time has my daughters stated wishes, to stay with me been acted upon by the Child support agency
- 6. At no time have any of my promptly replied letters been answered or acted upon in a satisfactory manner.
- 7. At no time have the agency verified my ex-wife's statements or mine to establish what is correct action for my daughters wellbeing
- 8. At no time has the agency visited in person, in any effort, to establish truthful facts.
- 9. At no time have I ever been approached for a means test
- 10. At no time has any considerations been given to my claims, before deductions were made from my bank account
- 11. At no time has the Agency ever acted upon the list of expenses I have given them in my letters which far out-weigh anything my ex-wife would have spent in the time considered.
- 12. At no time has the Agency enacted upon the obvious actions of my ex-wife who is obviously using my Daughter as a tool against me. personally
