SUBMISSION . INQUIRY INTO CHILD CUSTODY ARRANGEMENTS.

Dear Sir,

It is with a pounding heart and troubled Spirit that I make this personal submission into Child Custody Arrangement, after just having read an article that links VACCINATION to the CHILD CARE PAYMENTS BILL, NOVEMBER 11, 1997.
