- 12. "A number of parliamentary inquiries and their subsequent reports have taken detailed evidence and uncovered system corruption and illegality in family law institutions and practices and Parliament

refuses to act."

- 13. "Parliament has a duty to ensure that laws are followed and a duty to ensure that breaches of statutes are forwarded to Crown Law for investigation and where appropriate, prosecution."
- 14. "Australia's Family Law Act has a secrecy provision, section 121, which makes it an offense for any person to identify anything or any person to a family court case without the Chief Justice's approval."
- 15. Only 'approved' research can be admitted in court and the only officially 'approved' research institute is the Australian Institute of Family Studies which is an administrative arm of the Family Court itself.
- 16. An Australian politician suicided as a result of his own divorce.
- 17. Politician 'mates' in his own Labor party (the party which introduced the Family Law Act in 1975) wept in the parliament but not one mentioned the reasons he gave for his distress in the weeks up to his ending his life, his exclusion from his children. His suicide, and more importantly reasons for it were never officially recognized by the members of Parliament.
- 18. However, his sister and mother did talk openly and passionately about this and again the politicians refused to utter one word of recognition.
- 19. The politicians appear to have failed in their collective humanity and their duty to uphold the law and the system of government that is why we put them there and they demonstrably failed."

"NEW YORK -- A judge charged with taking gifts while on the bench has sued the prosecutor, accusing him of abusing his power by treating a disciplinary matter as a felony.

District Attorney Charles Hynes "is proceeding in excess of his jurisdiction" in the

case against Justice Gerald Garson, court papers filed Monday allege.

A spokesman for the prosecutor said he would respond in court "at the proper time." No immediate ruling on the matter was expected.

Garson was arrested in April for allegedly taking cash and gifts -- including a box of cigars -- to influence divorce cases. He has pleaded innocent to six felony counts of receiving reward for official misconduct.

The new defense filing argues that the alleged abuses violated the Judicial Code of Conduct, not criminal laws. It quotes the code as saying its rules "are not intended as a basis for criminal prosecution."
