Substance Abuse: two-day round-table Thursday 15 and Friday 16 August

The House of Representatives Standing Committee on Family and Community Affairs is to hold a two-day round-table as part of its inquiry into substance abuse in Australian communities.

The round-table, to be held at Parliament House in Canberra, will include presentations from experts in each of the subject areas being examined by the Inquiry, and involve discussions to further draw out evidence.

Session topics are:

- Health Care (including prevention and early intervention; current and new treatment options; adequacy of existing treatment services; consumer perspectives)
- Families (school and drug education; families with drug-addicted members)
- Workplace Safety and Productivity (prevalence and costs; current policies and programs; improving workplace safety and productivity)
- Road trauma (prevalence and costs; drink and drug driving)
- Crime, Violence and Law Enforcement (prevalence and costs; controlling the supply of illicit drugs; options for dealing with illicit drug crimes; drug abuse in prisons; law reform)

The full program is attached.

The House Family and Community Affairs Committee, Mrs Kay Hull MP, said the roundtable would be a valuable way for the Committee to work toward completion of the inquiry.

"The round-table will be a significant component of this inquiry, and will be important in helping the Committee refine its thinking on substance abuse in Australia," Mrs Hull said.

"In particular, it will help us draw out conclusions, and frame the recommendations that we might make to the government on this topic."

The inquiry started in March 2000 and issued a discussion paper in September 2001. The inquiry was readopted, with the intent of publishing a final report, with recommendations, as soon as possible.

The inquiry is examining the social and economic costs of the abuse of both legal and illicit substances. The committee will also be looking at how mental illness, in combination with substance abuse, affects the matters listed above.
