## Substance Abuse: two-day round-table Thursday 15 and Friday 16 August

The House of Representatives Standing Committee on Family and Community Affairs is holding a two-day round-table as part of its inquiry into substance abuse in Australian communities.

The round-table, to be held at Parliament House in Canberra (Committee Room 2R1), will include presentations from experts in each of the subject areas being examined by the Inquiry, and involve discussions to further draw out evidence.

The House Family and Community Affairs Committee Chair, Mrs Kay Hull MP, said the round-table would be a valuable way for the Committee to work toward completion of the inquiry.

"The round-table will be a significant component of this inquiry, and will be important in helping the Committee refine its thinking on substance abuse in Australia," Mrs Hull said.

"Listening to experience, seeing the problem, and establishing vital linkages will go a long way towards delivering solutions."
