INQUIRY INTO SUBSTANCE ABUSE

Substance Abuse round-table Day 2 - Friday 16 August

The House of Representatives Standing Committee on Family and Community Affairs is holding a two-day round-table as part of its inquiry into substance abuse in Australian communities.

The round-table, being held at Parliament House in Canberra (Committee Room 2R1), includes presentations from experts in each of the subject areas being examined by the Inquiry, and involves discussions to further draw out evidence.

DAY 2 - Friday 16 August

Session topics on Day 2 are:

- Road trauma (prevalence and costs; drink and drug driving)
- Crime, Violence and Law Enforcement (prevalence and costs; controlling the supply of illicit drugs; options for dealing with illicit drug crimes; drug abuse in prisons; law reform)

TOPIC 5 - CRIME, VIOLENCE AND LAW ENFORCEMENT (10.35am - 2.40pm)

(a) Prevalence and costs

Dr Adam Graycar, Director, Australian Institute of Criminology

The Australian Institute of Criminology conducts the innovative *Drug Use Monitoring in Australia* (*DUMA*) program, and findings from the study will be discussed by Dr Adam Graycar, Director, Australian Institute of Criminology.

The DUMA program tests recent use of illicit drugs by those apprehended by police. Using urinalysis the program ensures the most accurate data on recent drug use patterns is obtained. It provides unique data on patterns of drug use, local drug markets, criminal activity and treatment.

DUMA allows local police to monitor the impact of illicit drugs on their streets with high quality data. Such data enable police, policy makers and criminal justice practitioners to systematically assess and evaluate their street level drug markets.

Major Watters says recognising the important roles of both health and law enforcement in reducing drug use is vital. He says the national Illicit Drug Diversion Initiative currently being implemented across Australia shows that a legal response that is humane and compassionate to the users of illicit drugs by offering and encouraging treatment and support is far more likely to be effective in dealing with the problems underlying drug use, than by simply accepting or legitimising drug use as normal behaviour.

Dr Wodak argues the case for drug law reform. He says drugs are now recognised to be primarily a health and social issue, not a criminal issue. He argues that the criminal justice approach to drugs has not worked in the vast majority of countries, and that achieving better outcomes, especially reducing deaths, disease, crime and corruption, is more important than sending 'moral messages'. He says voters now want more effective and less expensive policies based on health and social interventions. Change is inevitable but the nature and timing of reforms is still unclear.
