## Substance Abuse inquiry to report this Monday

The House of Representatives Standing Committee on Family and Community Affairs will this Monday, 8 September, table the report of its inquiry into substance abuse in Australian communities.

The inquiry, which examined the social and economic costs of the abuse of both legal and illicit substances, started in March 2000 and issued a discussion paper in September 2001.

The inquiry was readopted, at the request on the Minister for Health, Senator Patterson, in mid-2002, with the intent of publishing a final report, with recommendations. The Committee held a number of additional public and private hearings, and a two-day roundtable with key groups, before finalising its report.

## INQUIRY TERMS OF REFERENCE

At the request of the Minister for Health and Ageing, the committee is to report and recommend on the social and economic costs of substance abuse, with particular regard to:

- family relationships;
- crime, violence (including domestic violence), and law enforcement;
- road trauma;
- workplace safety and productivity; and
- health care costs.

The committee also looked at how mental illness, in combination with substance abuse, affects the matters listed above.
