I wish to make a submission to the House of Representatives Standing Committee on Family, Community, Housing and Youth's Inquiry into Better Support for Carers.

I am submitting to the Inquiry because...

Disabled people deserve a better standard of living than they often have and their carers also.

Juge bureaucratic departments seem to serve themselves first + the people in need last.  More information is attached on a separate sheet

1. The role and contribution of carers in society

As a carer, I feel that my role is...

Completely undervalued by wider society and ~~not~~ not recognised officially by most Govt. Dep'ts. + agencies. eg. why does my daughter who already has enough problems have to wait endlessly in emergency departments, + is unable to access dental care when its needed. Transport costs are often unaffordable.  More information is attached on a separate sheet

2. The barriers to social and economic participation for carers

As a carer, I face the following problems ...

Completely exhausted my husband and I retired at 55 years and I had only been in the paid workforce - permanent part time for nine years as before then my caring role didn't allow for ~~not~~ regular work. My Super is near on worthless.  More information is attached on a separate sheet

To give our daughter an improved quality of life we are endlessly paying for extras - with no recompense - As long time carers we have almost forgotten what social life is.

3. The practical measures required to better support carers

As a carer, I need help with ...

Transporting our daughter at reasonable cost.  
Dental work which could only be done under anaesthetic  
at two major hospitals as my daughter's vagal nerve  
stimulator needed to be switched off & on again  
was postponed, cancelled etc ad nauseum until we went  
to the private section at ~~that~~ that hospital and paid  
over \$2000.00 - not tax deductible because our daughter is not  
dependent as she receives a disability pension - which does not  
cover all her  
monthly expenses, as is  
her  
extra  
expenses caring for their disabled person.  
eg transport, dental, medical, equipment.  
I am very angry that I could go to any  
expensive restaurant & see business people eating  
at the taxpayers expense  
but I can't even claim anything to do with her care  
- we have just spent \$2500.00 on a special bed for her.

Making it easy for carers to claim  
expenses caring for their disabled person.
