We only get approx \$100.00 per fortnight, which these days Only covers the cost of petrol. The carer's bonus was a help more would be useful. If we Were both unable to look after mum she would have to go into a nursing home, She is only 56 years old! Rehab were initially NOT

going to rehabilitate her if we were going to send her to a nursing home and not bring her home. If we did not fight for her she may not have survived!
