I wish to make a submission to the House of Representatives Standing Committee on Family, Community, Housing and Youth's Inquiry into Better Support for Carers.

As a Carer, I feel that my role is ... ALL INCLUSIVE CARE. eg. PERSONAL CARE/EMOTIONAL & PSY CHOLOGICAL SUPPORT (VERY IMPORTANT) FIN ANCIAL MANAGEMENT, PRACTICAL ASSISTANCE [GIVING-MY TIME OF 3, 6 TO 8 HOURS OR MORE PER DAY IF REQUIRED_ALSO TELEPHONE SUPPORT WHEN I CANT BE THERE.

I face the following problems ... LIKE MOST CARERS FATIGUE, STRESS AND ONES OWN HEALTH PROBLEMS_TAKING BUSES AND TAXIS IS VERY TIME CONSUMING, EXPENSIVE AND TIRING. IT USE THESE FOR MY CARING POLE. ... I AM UNABLE TO IMPROVE MY PRESENT OR FUTURE FINANCIAL PROSPECTS AS A CARER WHEN MY CARING POLE CEASES. I WILL REVERT BACK TO A PAY MENT EQUIVELANT TO THE DOLE. THE RENT ASSISTANCE PAYMENT HAS NOT INCREASED FOR A LONG TIME AND MY RENT HAS ALMOST DOUBLED IN THE LAST TWO YEARS (PRIVATE RENTAL) (ITS NOW MORE THAN 50% OF MY INCOME)

Increasing 6 monthly - A\$15-TAXI VOUCHERTO COVER 50% OF THE COST JOF THE FARE TO TRANSPORT MY MOTHERS SUPPLIES TO HER-CONDITIONS. Eq. 1 TRIP-ICARER-1 DESTINATION ONLY - PLEASE CONTINUE ANNUAL CARERS BONUS AS IT IS A GREAT HELP WITH MY DENTAL CARE ORTHOTICS AND OTHER MEDICAL NECESSITIES - THE BONUS IS ALSO ALMOSTEQUÍVELANT TO WHAT ONE COULD EARN ON A CENTRELINK PAYMENT, IF ONE WAS NOT A CARER...

I think the Government can better help Carers by ... CONTINUING TO SUPPORT THEM AFTER THEIR CARING ROLE CEASES DUE TO A DEFITH OF THE PERSON BEING CARED FOR, ESPECIALLY IF THEY ARE OVER 55 YAS AND UNABLE TO WORK FULL OR Phime, THE EX: CARER SHOULD AT LEAST BE PAIN THE EQUIVELANT OF A CARER PAYMENT UNTIL THEY REACH THE AGE PENSION AGE. MY FIRST CARING POLE CEASED THROUGH THE DEATH OF MY PARTNER, TWO MONTHS LATER I WASCARING FOR BOTH MY PARENTS: 3 MONTHS AFTER, MY FATHER DIED, NOW I CARE FOR MY 80 YE OLL MOTHER T ALSO HAVE UNOFFICIALLY BEEN CARING FOR MY 28 YE OLL DAUGHTER WHO HAS HAD LONG TERM MENTAL HEALTH PROBLEMS CARERS NEED CNGOING FINANCIAL ASSISTANCE ESPECIALLY AFTER A DEATH VERY THANK you for taking my views into consideration as part of the Committee's Inquiry. I look forward to much NEEDED. reviewing any recommendations you make to improve life for Carers in Australia.
