Social OUTINGS ARE INFREQUENT AS MY WIFE ALSO HAS Continence problems which makes moving away From Home a real drag For all concerned. Fuel prices are a deterrent to go anywhere. We are encouraged (and agree) its important to still "get out" but the above makes it very discouraging.

**3. The practical measures required to better support carers**

As a carer, I need help with ...

More frequent, perhaps Quarterly, meeting for Carers in Country Centres. The cost of Fuel/Accommodation etc. makes it very difficult for Rural people to attend meetings in State Capitals. I think it's very important (almost mandatory) that Carers have the opportunity to meet/talk with fellow Carers. This would allow people to re-assure one another.

**4. Strategies to assist carers to access opportunities and choices**

I think the Government can better help carers by ...

1. Cover the cost of Fuel/Accommodation to Attend Regular Meetings.
2. EXTEND Govt assistance (currently assists with Continence products) but really only covers 6 months of each year (in our case)
3. CARERS Payment @ \$100 per fortnight. e.g. \$7 per day does not cover much, in fact it tends to mentally degrade the worth of Carers. To keep patients at home, and not in Constitutional Care must save the Govt. huge outlays!
