I wish to make a submission to the House of Representatives Standing Committee on Family, Community, Housing and Youth's Inquiry into Better Support for Carers.

I am submitting to the Inquiry because...

More access for Carers to public areas for nearby parking. Mostly we have to drop our patient off at venue (where he has to stand and wait - no seats available) and Carer must then find a car park some distance away. More information is attached on a separate sheet

1. The role and contribution of carers in society

As a carer, I feel that my role is...

Caring for my husband night and day, to be ever watchful that he is on safe ground and does not fall or trip over objects, fall out of bed. He is totally dependent on me (Carer) 24 hours a day - to remember to take his medication or to go to bed or to eat his meal.

2. The barriers to social and economic participation for carers

As a carer, I face the following problems ...

I need to give my patient (husband) his evening medication before 4.30pm because, with his type of dementia he is delirious and verbally abusive after 4pm or so, as he suffers from " sundowners' dementia. He depends on me socially as he cannot communicate - he is also very deaf - isolated there also. More information is attached on a separate sheet
He relies on me to make constant contact with our family - so phone bills to mobile numbers are constant and expensive, but necessary.

3. The practical measures required to better support carers

As a carer, I need help with ...

General everyday and night care of patient
it is quite exhausting (and onerous) as it is so
constant. We realise that this caring by the
spouse is a great burden to the government, but we
are also elderly and with health worries and so it
is a huge, constant burden. More information is attached on a separate sheet.
I cannot see very well so have to take particular care.

4. Strategies to assist carers to access opportunities and choices

I think the Government can better help carers by ...
with details - medication etc.

Carers allowance being extended more in line with the
minimum wages. Cost of fuel to ~~the~~ patient to
various venues - exercise classes etc - is prohibitive

Apologies for writing I cannot see very well at all
