2. The barriers to social and economic participation for carers

As a carer, I face the following problems ...

I am unable to work full time as the day centre's hours are far to short.900am pickup and 4.00pm drop off.

The funding for futures is less than when they were at special school. Our young adults are bigger there disabilities are increasing and **your funding is less**.

Day centre's are under funded , under resourced ie not enough staff, not enough specialized service providers (physio and O.T.) not enough funding for longer hours to have decent programs.

I am getting older and my body is wearing out and having to continually fight for packages and services is mentally and physically draining.

The funding never covers the whole cost of aids, equipment. and renovations and their pension cannot cover the rest.

Carer allowance should be scaled to disability.

\$490 for 12 months not enough for incontinence aids. \$154.00 minimum spent each month on incontinence ,which adds up \$**1848** for 12 months quite a shortfall as you can see.
