I sincerely believe that there is far too little understanding by govt and departments of the issues that confront multicultural background carers. Certainly they believe in tight boxes where everything must conform, at least within some Vic Govt departments. But overall, we get "zip" support except

1. The role and contribution of carers in society

As a carer, I feel that my role is...

to work WITH other family members, agencies, welfare bodies etc to provide optimum care and support for our loved ones. This is usually with extremely limited if any support or funding and the bulk of the caring role placed solely on our shoulders. To ensure health is maintained, all accounts lawfully dealt with, home / property maintained, pets cared for, (etc)... so that their environment is maintained

2. The barriers to social and economic participation for carers

As a carer, I face the following problems ...

- 1) Nasty govt departments (eg Vic Dept of Education) which refuse to recognize the need for a carer to work close to the caree
- 2) Anglo Saxon attitudes that fail to understand that in a close knit ethnic family, care roles are split and that the eldest son or grandson will be have one set of roles and the eldest daughter or granddaughter other roles.
- 3) Lack of money / support from government
- 4) Extremely limited money from govt to relevant welfare agencies e.g. Australian Greek Welfare Society.

3. The practical measures required to better support carers

As a carer, I need help with ...

- 1) Government department policies and conduct
- 2) Lack of funded agencies, respite care, support services, sufficient day care facilities, sufficient planned activity programs... ie fund more!
- 3) Translated material in different languages
- 4) More nursing homes and qualified staff; the latter demands subsidized courses for carers and staff of relevant welfare units and agencies.

4. Strategies to assist carers to access opportunities and choices

I think the Government can better help carers by ...

- 1) see all the foregoing points, especially re how poorly state government departments (federal too ???) fail abjectly to support employees who are also carers and who effectively bully them by refusing to act in a supportive role
- 2) (a) tax discounts/deductions for carers
(b) increased funding per above
(c) GST free aides for carers

- 3) (d) communicate with ethnic communities about our very serious issues which are barely covered by existing bodies outside of our own communities
