Pension does not go far. Single Refugees get monthly allowance of \$1,890,00 and an additional \$580.00 in social assistance. Pensioners receive \$1,012.00. After paying 50 years of taxes, to the Government. I would like to work (full-time or part-time) but have the following issues to deal with

At 67 years still working, a few hours to supplement part pension, with help, from my daughter, to assist with my disabled son.

I worry about my future because ...

I worry about my sons future, if I become ill or die, What happens to him then?

The lack of quality housing and care for disabled is appalling. More financial support for housing and care is desperately needed from the government.

The things that stress me the most about being a Carer are ...

Very little support, from government, how long can I keep doing this caring role, before health fails.

I think the Government can better help Carers by ...

Funding to provide quality housing and care for the disabled, and to listen to what the parents want, for their loved ones, instead of telling them how it will be! After all we are the voice of our children Who cannot speak for themselves?
