

# Submission to the Inquiry into IT Pricing - July 2012

## Why do prices differ for training delivered via technology?

This submission relates to the purchase of (the use of) technology for training purposes.

As an alternative to classroom-based training, many training courses can be purchased online, including training provided by companies for their own software products.

I have found examples of public courses where the Australian price is higher than the US price by between 27% and 50%.

In these examples, the courses appear to be the same delivery format, topics and duration, but are displayed on "Country" specific web pages with differences in:

- the course code (where the Australia course code has the suffix "AU"); and
- Pricing.

## Example 1: Cognos Report Studio: Introduction (V10.1) - eLearning<sup>1</sup><sup>2</sup>

"..This eLearning offering is a Web-based Training (WBT)... interactive multimedia modules that are intuitive and instructionally sound. Through visual content, product demonstrations, hands-on learning activities, and assessment quizzes..."

## 50% price difference

A 50% discrepancy exists between the US price and the Australia price as illustrated in the table

below.

### 27% price difference

A 27% discrepancy exists between the US price and the Australia price as illustrated in the table

below.

J2158 (See Footnote 4)	USD \$1,680.00 plus tax

While I haven't reviewed other vendor sites, I suspect that similar "Country" pricing disparities exist for their offers.
