Re: Submission by Warringah Council on the New Inquiry into the National Broadband Network

Warringah Council welcomes the opportunity to contribute its views on the National Broadband Network, which it considers has the overall potential to deliver much needed communications infrastructure locally and regionally, with significant sustainable economic, as well as social benefits to the community.

Council's support for the National Broadband Network and for the capacity of the roll out to contribute locally and regionally is outlined in relation to the specific points below:-

a) The delivery of Government services and programs:

The said broadband services will create opportunities for improved service within the local government and Northern beaches area by promoting and enhancing eservices. This would enable the Council to improve its level of efficiency while minimising costs due to reduced overhead costs and effective delivery.

 Improving the educational resources and training available for teachers and students:
