EXECUTIVE MINUTE

on

JOINT COMMITTEE OF PUBLIC ACCOUNTS AND AUDIT REPORT [No. 396] [REVIEW OF AUDITOR-GENERAL'S REPORTS, 2002 – 2003, FIRST, SECOND AND THIRD QUARTERS]

General comments

The JCPAA report No 396 provided two recommendations in relation to the Australian National Audit Office (ANAO) report into Facilities Management at HMAS Cerberus (Audit Report No 3, 2002 –2003). Of particular concern to the JCPAA were issues relating to Defence's follow-up of Inspector-General, ANAO and JCPAA recommendations.

Response to the recommendation(s)

Recommendation No. 2 paragraph 3.33

The Department of Defence should immediately update its Audit Recommendations Management System and provide the Committee and the Australian National Audit Office with a report on the current status of all Committee and Audit Office recommendations.

Recommendation No. 2 paragraph 3.34

The Committee expects Defence to review its instructions concerning the use of ARMS and its monitoring arrangements to ensure that the system is being correctly used to monitor Defence's progress in completing the requirements of the recommendations to which it has agreed.

Defence supports this recommendation and is continuing to make progress in their implementation.

The Defence Committee (DC), at its meeting on 21 June 2000, determined that the Inspector-General would provide a standing report on audit recommendations. The Inspector-General reports to the DC 5 times per annum on the implementation status of recommendations. The purpose of the report is to advise the DC on progress with the implementation of all audit recommendations in Defence raised by the Joint Committee of Public Accounts and Audit (JCPAA), Australian National Audit Office (ANAO) and the Inspector-General, and to report on the overdue/unactioned recommendations for each Group.

The Defence Audit Committee (DAC) is responsible for reviewing internal and external audit reports and providing advice to the Secretary on action to be taken. The Inspector-General reports to the DAC 5 times per annum on the implementation status of recommendations. This information is also made available to the Australian National Audit Office since the Auditor- General's representatives attend as observers.

As requested, the following is a summary of the implementation of JCPAA and ANAO audit recommendations in Defence as at 31 December 2003, and the overdue/unactioned recommendations for each Group.

Overview

Active recommendations have gradually increased (Table A) during the year from 106 at 31 Dec 02 to 134 at 31 Dec 03, and there were marginally more JCPAA and ANAO recommendations entered on ARMS during 2003 (143) than in 2002 (128).

Overdue recommendations increased from the particularly good low of 2 at 31 Oct 03 to 5 at 31 Dec 03 (Table C). This figure compares favourably with the 16 overdue recommendations at 31 Dec 02.

Trend Analysis

Table B details the active and overdue recommendations by Group, and summarises the recommendations by organisation and category. 3 new recommendations (2 ANAO and 1 JCPAA) were entered on ARMS during the period, of which 1 was a high priority recommendation and 2 were lower priority recommendations.

Table C shows the proportion of active and overdue recommendations for the 12 months 31 Jan 03 to 31 Dec 03. Overdue recommendations decreased significantly during the year from 18 at 31 Jan 03 to 5 at 31 Dec 03, although active recommendations increased from 106 at 31 Jan 03 to 134 at 31 Dec 03.

The status of high priority recommendations is shown in **Table D**. There were **35** active high priority recommendations at 31 Dec 03, a decrease of **9** since 31 Oct 03. Overdue high priority recommendations increased from **0** to **2** during the period. These overdue high priority recommendations belonged to Chief Finance Officer and Defence Materiel Organisation (DMO). As shown in **Table E**, the DMO overdue recommendation was completed 30 Jan 04.
