JOINT COMMITTEE OF PUBLIC ACCOUNTS AND AUDIT Report No. 412: Audit reports reviewed during the 41st Parliament

General Comments

The JCPAA Report No. 412 made two recommendations (Recommendations 28 and 38) specific to the Department of Health and Ageing. The Department considers that both recommendations are administrative. The Department's responses to these recommendations are set out below.

The Report also made three other recommendations (Recommendations 8, 9 and 16) to all agencies. The Department of Finance and Deregulation advised that formal agency responses to these recommendations are not required.

DEPARTMENT OF HEALTH AND AGEING RESPONSES TO RECOMMENDATIONS 28 and 38

Recommendation 28

The Committee recommends that as far as possible, Health attempt to have as many contracts signed as possible prior to a project beginning and funding being dispersed. Where contracts are not signed beforehand, the Committee recommends that elements which are easily defined be entered into an interim contractual measure.

Department of Health and Ageing Response

The Department supports this recommendation. The Department has enhanced its procurement and contracting procedures, including the development and implementation of a letter of offer that makes it clear that work is not to commence until the other party receives an executed contract.

Recommendation 38

The Committee recommends that DIAC and DoHA revise their training programs to include a focus on improving staff skills in performance monitoring and assessment to assist in greater departmental compliance with performance management requirements.

Department of Health and Ageing Response

The Department supports this recommendation. The Memorandum of Understanding (MoU) between DIAC and the Department sets out the responsibilities of the two agencies in relation to the provision of health advice. The Department maintains regular communication with DIAC in relation to the performance of activities under the MoU.
