## **RESPONSE TO QUESTION AT HEARING**

Question from Senator Watson: When did you first feed that information up the line to ensure that there could have been a better criterion than self-selection.

We have been unable to identify an exact date.

When take up numbers were not as large as expected, Centrelink and the Department of Agriculture, Fisheries and Forestry (DAFF) worked together to understand what was happening.

Centrelink staff in rural areas reported that some farmers were not applying for assistance, as they believed they would not be eligible. This observation was shared with relevant officers in the Department of Agriculture, Fisheries and Forestry (DAFF).

A strategy was put in place early in the delivery of the drought package to discourage this self-selecting out of potential assistance. A communication campaign was organised using local radio and press to address this issue directly and encourage farmers to test their eligibility. Seminars were also organised for farmers to receive more detailed information and again they were encouraged to test their eligibility.
