Officers from the Department visited 156 councils during 2005/06. Of these, 57, or 37%, were fully complying in terms of the signage requirements at the time of inspection and of the 1,550 projects physically inspected, 1286 projects, or 83%, were complying at the time of the visit. All councils were asked to address any non compliance issues.
