Outcome 1 Topic: Australian Overseas Projects Corporation

Mr Baird asked:

What would be the overall size of the consulting projects that we won in the Middle East last year? [in terms of numbers of projects]

Answer:

Austrade directly assisted Australian companies to win 8 consulting projects in the Middle East last year (2001), with a combined value of \$283 million. These included:

- Project design and feasibility studies for mineral reserves projects
- Engineering and construction services for tourism projects
- Front-end engineering and design work (FEED) for oil & gas projects
- Feasibility studies and other consulting projects associated with agricultural developments
- Education and vocational training services.

We do not have detailed information on other consultancy projects that Australian companies might have won in the region.

Outcome 1 Topic: Beijing Olympics Contracts

Mr Baird asked:

Have you got any estimate on how much it (Beijing Olympics 2008) is worth to Australia so far in terms of contracts that have been written specifically Olympic related?

Answer:

To Austrade's knowledge there have as yet been no specifically Olympic related contracts written in terms of the Beijing Games 2008. However, the Beijing authorities are still in the preliminary phase of planning the roll-out of the various projects relating to the Beijing Olympics. No contracts have been awarded yet but two design competitions have recently been announced.

- The two competitions are for the overall design (master-planning) of both major sports venue sites (the Olympic Green and the Wukesong Sports and Cultural Centre in the west of Beijing) and were open for registration from 2-15 April.
- 177 design firms have made submissions, several of these being Australian.
- Design submissions are due in early July with the decision on the winning designs expected in late July/early August. A cash prize will be awarded for the winning designs.

Austrade is working with many companies from a broad range of sectors to help position them to win Olympic business as specific Olympic tenders and related business opportunities arise.
