Expanding Australia's trade and investment relations with the Gulf States

Second and third public hearing: Wednesday 7 April 2004 Sydney & Melbourne

As part of its inquiry into **Expanding Australia's trade and investment relations with the Gulf States**, the Trade Sub-Committee of the Joint Standing Committee on Foreign Affairs Defence and Trade will hold the second and third of four public hearings this coming Wednesday 7 April in Sydney & Melbourne.

The inquiry was established to examine and report on ways to expand Australia's trade and investment relationship with the economies of the Gulf States (Bahrain, Kuwait, Oman, Saudi Arabia, the United Arab Emirates, Qatar and Iran), paying particular attention to:

- The nature of Australia's existing trade and investment relationships with the region;
- · Likely future trends in these relationships; and
- The role of Government, particularly the Department of Foreign Affairs and Trade (DFAT), Austrade and the Export Finance and Insurance Corporation (EFIC), in identifying and assisting Australian companies to maximise opportunities in the Gulf States as they emerge.

Following the Canberra hearing last week and hearings held in Sydney and Melbourne this week, there will be a final hearing held in June (details to be advised).
