The Queensland Tourism Industry Council (QTIC) welcomes the opportunity to make this submission to the Joint Select Committee on northern Australia, to help inform and shape the Committee's recommendations to the Parliament for the development of a white paper.

As the peak industry body for tourism in Queensland, QTIC strongly supports growing the tourist economy as a key priority of the White Paper process for the Development of Northern Australia, and supports the submission made by Advance Cairns (attached).

In addition to the submission provided by Advance Cairns, QTIC makes the following representations:

- References to growing the tourism market should be broadened from just looking at the international tourist market and include the domestic market which currently attracts more visitors and more expenditure.
- QTIC strongly supports the recommendation by Advance Cairns that addressing the entrenched disadvantage faced by Indigenous communities must be a core component of both the Committee's report to Parliament and the development of a Northern Australia White Paper. In particularly, the rate of Indigenous persons participating in the workforce must significantly increase, which will also require Government support for Indigenous business opportunities such as Indigenous Tourism.
- Further to actions around infrastructure, policy support should be given to the development of new and innovative products, tourism experiences and supporting services. Nature-based tourism must remain an economic strength for the region, and Indigenous tourism and adventure tourism should be promoted through government policy and initiatives.
- Tourism interests must be considered a priority opportunity when dealing with matters that are cross-industries. Global best-practice should be aspired to when considering state- and nationwide development projects.
