DEAR SIRs.


IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY BE RATIFIED ,HOWEVER WITH RESERVATION. WHILE THE EXECUTIVE SUPPORTS PROTECTIONS OF INTERNATIONAL PATENTS , AND ALL INTELLECTUAL PROPERTY . WE ARE CONCERNED AT THE FEES AND CHARGES , NOT OUTLINED IN THIS TREATY. WE WOULD LIKE TO KNOW WHAT OUR INTERNATIONAL TREATY OBLIGATIONS ARE COSTING AUSTRALIA . AS NO BUDGET EXISTS IN RELATION TO TREATY OBLIGATIONS , WE WOULD LIKE THE JSCT TO PROVIDE US WITH A COSTING. WE ARE ALSO INTERESTED IN KNOWING IF THIS TREATY IS BINDING ON AUSTRALIA , AS WE HAVE BEEN INFORMED BY THE FEDERAL ATTORNEY - GENERAL THAT NOT ALL TREATIES ARE BINDING ON AUSTRALIA . WE CANNOT UNDERSTAND WHY WE RATIFY TREATIES IF THEY ARE NOT BINDING, AND WHY WE CONTINUE TO PAY OUT LARGE SUMS OF MONEY FOR SUCH TREATY OBLIGATIONS IF NO SUCH OBLIGATIONS EXIST. IF SO CALLED AUSTRALIAN LAW OVER RIDES THESE INTERNATIONAL AGREEMENTS AND MAKES THEM NUL AND VOID , WHAT IS THE REASON . IS THE REASON THE COMING NEW WORLD ORDER , OR THE COMING AUSTRALIAN REPUBLIC. THE GOVERNMENT WHO ARE THE PEOPLE DESERVE TO KNOW WHERE , WHY , AND HOW OUR TAX DOLLARS ARE GOING , ALSO HOW MUCH EACH YEAR LEAVES AUSTRALIA . AS THIS EXECUTIVE IS THE VOICE OF THE GOVERNMENT ( THE PEOPLE ) WE REQUEST THAT INFORMATION. THIS EXECUTIVE DOES NOT SUPPORT THE CONCEPT THAT WE MUST RATIFY EVERY TREATY.
