DEAR SIRs.


IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY BE RATIFIED . WE FULLY SUPPORT THE FACT THAT EVERYONE SHOULD PAY TAX, HOWEVER THE (ATO) ADMIT THAT THEY ARE NOT A LEGAL ENTITY, THEY CANNOT APPEAR BEFORE THE HIGH COURT OF AUSTRALIA BECAUSE THEY ARE NOT A LEGAL ENTITY . THERE FOR IT WOULD NOT BE LEGAL TO BE A PARTY TO THIS TREATY . A FEDERAL REFERENDUM WOULD BE REQUIRED TO MAKE THE ATO A LEGAL ENTITY , WE DO NOT BELIEVE THAT THE AUSTRALIAN PEOPLE WOULD CARRY THAT PROPOSAL . NO PERSON SHOULD BE ALLOWED TO AVOID TAXATION UNDER THE COVER OF A TAX SHELTER . WE FULLY SUPPORT THE NEED FOR SUCH A TREATY , HOWEVER MULTINATIONALS DO NOT PAY TAX ON PROFITS , THAT IS UNDER INTERNATIONAL AGREEMENTS , WHY SHOULD GREED BE REWARDED . WE THE VOICE OF THE GOVERNMENT (THE PEOPLE) CALL ON THE PARLIAMENT TO CLOSE THE DOOR ON MULTINATIONAL AVOIDANCE . ASKING THE ATO TO ADMINISTER THIS TREATY IS LIKE ASKING NED KELLY TO LOOK AFTER A BANK , SUCH AGREEMENTS SHOULD BE MANAGED BY TREASURY , THE TAX OFFICE SHOULD BE ABOLISHED , COULD YOU PLEASE EXPLAIN HOW THE TAX COMMISSIONER CAN ASK FOR MONEY , THAT IS THE PERSONAL REQUEST FOR MONIES , TO BE LEGAL IT HAS TO BE COLLECTED ON THE BEHALF OF THE PEOPLE OR THE PARLIAMENT , NOT THE COMMISSIONER . TAXATION IS A COMPELLED BENEFIT , NOT AN AGREEMENT BETWEEN TWO PARTIES . UNLESS THE RULE OF LAW APPLIES THEN THE LAW IS NUL AND VOID . IT AFFORDS NO
